

Notice of Rate Increase
Proceeding 22AL-0137CP

Wilson Peak Limo, LLC, dba Mountain Limo filed changes to the call-and-demand charter, shuttle and taxi fares in Passenger Tariff, Colorado PUC No. 2 on March 30, 2022, that result in increases to the existing fares for the transportation of passengers between points in the Telluride area and between Telluride, Montrose, and Grand Junction. The proposed effective date of the increased fares is May 1, 2022.

To participate in the hearing, a party must also file a written intervention and receive leave of the Commission to intervene. Requests to intervene as a party must comply with Commission rules.
